MINUTES

CITY OF HIALEAH GARDENS TUESDAY, June 4, 2024 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Councilman Elmo Urra, Councilman Jorge Gutierrez, Councilman Jorge Merida, Councilman Rolando Piña, Chairman Luciano Garcia, Mayor Yioset De La Cruz, and Ms. Aida Martinez-Ruiz, City Attorney.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- 5. Deletions/Emergency Additions N/A
- **6. Review of Minutes:** May 21, 2024 Chairman Garcia made a motion to approve the minutes of **May 21, 2024**. The motion was approved unanimously.
- **7. Public Comments:** At this time, Ms. Annabelle Urrea Guzman came forward and introduced herself as the new governmental community affairs liaison to Mayor Daniella Levine-Cava. She wanted to formally introduce herself in person and offer her services to the City and Mayor.

8. Opening of sealed bids for PW-24-106 Utility Work Okeechobee Frontage Road from E. of 116 Way to E. of NW 87 Avenue: Mr. Joe Lopez, Public Works Director.

Mr. Joe Lopez, Public Works Director, came forward. Two bids were submitted to the City. Mr. Lopez opened the first bid, from Marcdan Inc., which had a base bid price of \$4,055,720.00. He opened the second bid, from Acosta Tractors Inc., had a base bid price of \$4,099,872.95. Mr. Lopez stated that the Department would review these and come back to the Council with a recommendation.

9. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE AWARD OF A CONTRACT FOR SOUTH DISTRICT DRAINAGE IMPROVEMENTS NW 95TH STREET FROM 77TH AVENUE TO 79TH AVENUE (PW 24-105); AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH ACOSTA TRACTORS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the resolution into the record. Mr. Joe Lopez, Public Works Director, came forward to explain the background of this project (PW 24-105). The funding source is state grant LPA-0537 with a grant amount of \$350,000. The department recommends that the Council award the contract to Acosta Tractors, Inc., for a contract amount of \$326,690.52 as the lowest responsive responsible bidder. There were no further questions or comments. The Chair made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(5-0)**

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE AWARD OF A CONTRACT FOR UTILITY IMPROVEMENTS NW 107TH AVENUE FROM 138TH STREET TO NW 147TH STREET (WS 24-107); AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH ACOSTA TRACTORS; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

The resolution was approved unanimously. Mr. Joe Lopez, Public Works Director, came forward once again to explain the background of this project (WS 24-107). The funding source is the Water & Sewer Department construction account. The department recommends that the Council award the contract to Acosta Tractors, Inc., for a contract amount of \$598,169.04 as the lowest responsive responsible bidder. There were no further questions or comments. The Chair made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(5-0)**

RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, C) AUTHORIZING THE PURCHASE OF THREE (3) 2025 FORD POLICE INTERCEPTORS UTILITY VEHICLES TO BE USED BY THE **POLICE DEPARTMENT PATROL** UNITS; AS **WAIVING** COMPETITIVE BIDDING; UTILIZING ΑN **EXISTING** GOVERNMENT CONTRACT AS ALLOWED BY SECTION 46-121 OF THE HIALEAH GARDENS CODE OF ORDINANCES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS EXECUTE AN AGREEMENT WITH ALAN JAY FLEET SALES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the resolution into the record. Captain Michael Lopez, of the Hialeah Gardens Police Department, came forward to speak on the item. On behalf of Chief Luis Diaz, the Department is respectfully requesting the approval of this resolution to purchase (3) 2025 Ford Police Interceptor utility vehicles. These three vehicles will be issued to augment the Patrol [division] fleet for a total amount of \$189,150.00 via government contract. Price includes the outfitting and graphics. Mayor De La Cruz spoke, explaining that items C, D, and E, if approved, will be funded with federal monies [in the City's surplus] that have to be used by September. These funds have to be used either for utilities or police safety equipment. There were no further questions or comments. The Chair made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(5-0)**

D) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE PURCHASE OF FIVE (5) 2025 FORD POLICE INTERCEPTORS UTILITY VEHICLES TO BE USED BY THE POLICE DEPARTMENT FOR THE SERGEANTS; WAIVING COMPETITIVE BIDDING; UTILIZING AN EXISTING GOVERNMENT CONTRACT AS ALLOWED BY SECTION 46-121 OF THE HIALEAH GARDENS CODE OF ORDINANCES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH ALAN JAY FLEET SALES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the resolution into the record. Captain Michael Lopez, of the Hialeah Gardens Police Department, came forward once again to speak on the item. The Department is respectfully requesting the approval of this resolution to purchase (5) 2025 Ford Police Interceptor utility vehicles for the Sergeant [division] for a total amount of \$306,240.00 via government contract. This will serve to replace current Sergeant vehicles which will transferred for use by Patrol operations. Price includes outfitting and graphics. There were no further questions or comments. The Chair made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(5-0)**

E) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE PURCHASE OF SIXTY (60) NEXT GENERATION APX NEXT PORTABLE RADIOS TO BE USED BY THE POLICE DEPARTMENT; WAIVING COMPETITIVE BIDDING; UTILIZING AN EXISTING GOVERNMENT CONTRACT AS ALLOWED BY SECTION 46-121 OF THE HIALEAH GARDENS CODE OF ORDINANCES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH MOTOROLA SALES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the resolution into the record. Captain Michael Lopez, of the Hialeah Gardens Police Department, came forward once again to speak on the item. The Department respectfully requests the approval of this resolution to purchase (60) Next Generation APX Next Portable Radios. This purchase is through a contract via Miami-Dade County in the amount of \$600,000. Captain Lopez stated that the current radios in use by the Department will become obsolete and the new equipment will serve to completely replace the current radios. The Next Generation APX radios include the ability to connect to radio towers and to cell phone towers. They also include a GPS tracking system and screen messaging. It is fully compatible with the County and other municipalities.

There were no further questions or comments. The Chair made a motion to approve the resolution, seconded by Councilman Merida. The resolution was approved unanimously. **(5-0)**

Ms. Martinez-Ruiz read the resolution into the record. Ms. Kerri Barsh, attorney, came forward on behalf of the applicant, White Rock East, LLC. This is a first reading; an opportunity for input would be afforded at the next meeting. The Chair made a motion to approve the ordinance upon first reading, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(5-0)**

12. Second Reading / Public Hearing for consideration and final adoption of the following ordinances:

Ms. Martinez-Ruiz read the resolution into the record. At this time Ms. Martinez-Ruiz swore in all individuals intending to give testimony on any of the following items.

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING A SITE PLAN FOR AMC PARK I TO DEVELOP A NEW TRUCK PARKING AND AN OFFICE BUILDING, CONCERNING PROPERTY LEGALLY DESCRIBED AS: TRACT "A" WEST 1/2 OF THE WEST 1/2 OF TRACT 58 OF FLORIDA FRUIT LANDS COMPANY'S NO. 1, SECTION 19, TOWNSHIP 52 SOUTH, RANGE 40 EAST, ACCORDING TO THE PLAT THEREOF, AS RECORDED IN PLAT BOOK 2, PAGE 17, OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA; LESS AND EXCEPT THAT PORTION CONVEYED TO THE CITY OF HIALEAH GARDENS BY RIGHT-OF-WAY DEED RECORDED DECEMBER 23, 2011 IN OFFICIAL RECORDS BOOK 27940, PAGE 122 OF THE PUBLIC RECORDS OF MIAMI-DADE COUNTY, FLORIDA. Ms. Martinez-Ruiz read the resolution into the record. Mr. Miguel Cabrera, architect for the project, came forward on behalf of the applicant and stated his name and address for the record. Mrs. Mirtha Gonzalez, Chief Zoning Official, came forward and read a memorandum for recommendation into the record. She mentioned that at the Planning & Zoning meeting, Mr. Andy Perez, a P&Z Board member recommended that the site should be paved. Ms. Martinez-Ruiz clarified

the issue, explaining that Mr. Perez had raised concerns about DERM requirements and the possibility of contaminants leaking into the ground [on this site] due to the truck parking use. The motion at the P&Z meeting was to approve the item with the recommendation, within the limits of a recommending body. Mr. Cabrera was in agreement with this at the P&Z meeting but emphasized that this project still has to go through DERM permitting which has layers of environmental requirements...the City code does not currently require paving on sites like these as DERM has the expertise and authority on these issues.

Public hearing opened at 7:52 p.m.; no one came forward. Public hearing closed at 7:52 p.m. No further questions or comments. The Chair made a motion to approve the ordinance upon second reading, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(5-0)**

Ms. Martinez-Ruiz read the resolution into the record. Mr. Miguel Cabrera, architect for the project, came forward once again on behalf of the applicant and stated his name and address for the record. Mrs. Mirtha Gonzalez, Chief Zoning Official, came forward and read a memorandum for recommendation into the record. This is the same type of project as the previous item [on a neighboring folio]. Recommendations were addressed by the applicant. No variances.

Public hearing opened at 7:54 p.m.; no one came forward. Public hearing closed at 7:54 p.m. No further questions or comments. The Chair made a motion to approve the ordinance upon second reading, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(5-0)**
