#### **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, February 19, 2019 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Councilman Elmo Urra, Councilman Jorge Gutierrez, Councilman Jorge Merida, Councilman Rolando Piña, Chairman Luciano Garcia, and City Attorney Charles Citrin. Mayor Yioset De La Cruz was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** City Attorney Citrin led the pledge of allegiance.
- **5. Deletions/Emergency Additions:** None were offered. Mr. Citrin switched the order of items B and C.
- **6. Review of Minutes: February 5, 2019** Chairman Garcia made a motion to approve the minutes of February 5, 2019, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

### 8. First Reading for consideration of the following ordinances:

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, AMENDING THE OFFICIAL ZONING MAP OF THE CITY OF HIALEAH GARDENS APPROVING THE REZONING OF 148,442 SQUARE FEET MORE OR LESS OR 3.408 ACRES APPROXIMATE LOCATED AT WEST SIDE OF NW 112TH AVENUE AND BETWEEN NW 140TH STREET AND THEORETICAL NW 141ST STREET, HIALEAH GARDENS, FLORIDA, FROM IN-1 (LIGHT INDUSTRIAL USE) TO HEAVY INDUSTRIAL (IN-2). FOLIO #: 27-2019-001-0395; DECLARING THIS ZONING MAP AMENDED TO BE CONSISTENT WITH THE COMPREHENSIVE PLAN OF THE CITY OF HIALEAH GARDENS PROVIDING FOR SEVERABILITY, PROVIDING FOR AN EFFECTIVE DATE. This is a first reading; an opportunity for public input would be afforded upon second reading. The Chair made a motion to approve the item upon first reading, seconded by Councilman Merida. The motion was approved unanimously by individualized voice vote. **(5-0)**

## Second Reading / Public Hearing for consideration and final adoption of the following ordinance:

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS SECTION 78-156(e) OF THE AMENDING DEVELOPMENT REGULATIONS IN THE CODE ORDINANCES OF THE CITY OF HIALEAH GARDENS, FLORIDA, BY **PROVIDING** THAT **APPLICATIONS** BY **MICRO WIRELESS** AND **SMALL** WIRELESS TELECOMMUNICATIONS FACILITIES (AS DEFINED IN AMENDED SECTION 78-156(e)) FOR INSTALLATION OR CONSTRUCTION IN RIGHT OF WAYS OR PUBLIC ROADS UNDER FLORIDA STATUTES 337.401(3)(a) ARE NOT REQUIRED TO OBTAIN SITE PLAN REVIEW OR APPROVAL FROM THE CITY, SETTING FORTH THOSE CONDITIONS; PROVIDING FOR INCLUSION IN CODE; PROVIDING FOR SEVERABILITY: PROVIDING FOR REPEAL OF ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR EFFECTIVE DATE.

This is a City sponsored item. Mr. Citrin swore in those intending to give testimony on the item and proceeded to read the item into the record. Mrs. Mirtha Gonzalez, Chief Zoning Official, came forward and detailed the need to provide language in the code that allows micro wireless facilities and small wireless facilities to be approved without requiring the site plan review process. Instead, they can apply for building permits and go through that process. A large tower, however, would still require a site plan because those are huge structures over 100 feet tall. This is new technology that only involves placing small network-connected boxes on existing power or telephone poles. Councilman Gutierrez asked if there would be any language that would limit the number of boxes they could install in the City. Chairman Garcia and Mrs. Gonzalez answered that they only would have to go through the permitting process. Mr. Citrin asked about application fees. Mrs. Gonzalez responded that there is a regular building permit fee and a new antenna fee at this time. Mr. Citrin added that the City is limited in their rights but because they can charge fees, a review will determine what that fee would be. Chairman Garcia opened the public hearing at 7:45 p.m.; no comments were offered, public hearing closed at 7:45 p.m. No further guestions or comments from the Councilmembers. The Chair made a motion to approve the item, seconded by Councilman Merida. The motion was approved unanimously by individualized voice vote. (5-0)
