CITY OF HIALEAH GARDENS TUESDAY, April 16, 2019 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:30.
- **2. Roll Call:** Present were Councilman Elmo Urra, Councilman Jorge Gutierrez, Councilman Jorge Merida, Chairman Luciano Garcia, Mayor Yioset De La Cruz, and City Attorney Charles Citrin. Councilman Rolando Pina was absent.
- **3. Invocation:** Chairman Garcia gave the invocation
- **4. Pledge of Allegiance:** Mayor De La Cruz led the pledge of allegiance.
- **5. Deletions/Emergency Additions:** Item 8B was deleted from the agenda.
- **6. Review of Minutes: April 2, 2019** Chairman Garcia made a motion to approve the minutes of April 2, 2019, seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None offered.

8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE PURCHASE OF ONE (1) 2019 FORD F-550 FORD PICKUP TRUCK FOR THE USE OF THE AND SEWER DEPARTMENT; WATER WAIVING COMPETITIVE BIDDING; UTILIZING AN **EXISTING** GOVERNMENT CONTRACT; **AUTHORIZING** THE OFFICIALS TO EXECUTE APPROPRIATE CITY AGREEMENT WITH DUVAL FORD, LLC; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

Mr. Citrin read the item into the record. Mr. Andres Delgado, Water & Sewer Director, came forward to respectfully ask for approval to purchase a Ford Pickup F-550. Chairman Garcia asked what the total amount of the purchase would be. Mr. Citrin answered that the total would amount to \$42,387. Mayor De La Cruz informed that the original purchase was going to be for a Ford F-150 but it was decided that it would not be sufficient for the needs of the W& S Department, which include towing large equipment. The item intended for the purchase of the F-150 was deleted from the agenda (8B). The funds for the purchase have been allocated for in the budget. Mr. Citrin pointed out that "Duval Ford, LCC" within the legal description needed to be corrected to "Duval Ford, LLC." Chairman Garcia made a motion to approve the resolution, seconded by Councilman Merida. The item was approved unanimously. (4-0)

Chairman Garcia opened the public hearing at 7:35 p.m., no comments were offered and he closed the public hearing 7:35 p.m. Chairman Garcia made a motion to approve the ordinance, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(4-0)**
