## **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, June 18, 2019 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- 1. Call to Order: Chairman Garcia called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Councilman Elmo Urra, Councilman Jorge Gutierrez, Chairman Luciano Garcia, Mayor Yioset De La Cruz, and City Attorney Charles Citrin. Councilman Rolando Piña and Councilman Jorge Merida were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De la Cruz led the pledge of allegiance.
- **5. Deletions/Emergency Additions:** N/A
- **6. Review of Minutes: June 4, 2019** Chairman Garcia made a motion to approve the minutes of June 4, 2019, seconded by Councilman Gutierrez. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

**8.** Presentation of KAPOW (Kids and the Power of the Workplace) Award: Mr. John Casbarro, President of Learning for Success, Inc., and Ms. Sharon Gonzalez, Principal of West Hialeah Gardens Elementary School.
