## **MINUTES**

- **1.** Call to Order: Chairman Garcia called the meeting to order at 7:34 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Elmo L. Urra, Councilman Jorge Gutierrez and City Attorney Charles A. Citrin. Councilman Rolando Piña and Mayor Yioset De La Cruz were absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mr. Citrin led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions**: None were offered.
- **6. Review of Minutes: January 17, 2017,** Chairman Garcia made a motion to approve the minutes of January 17, 2017 seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the full title of the resolution into the record. This is a city initiated resolution as to the use and operation of the museum and library. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the ordinance into the record. Mr. Edwin Bartos, Attorney for the applicant was present. Mrs. Mirtha Gonzalez, Chief Zoning Official, came forward and gave staff recommendations for approval of the land use amendment from BU (Business Designation) to HDR (High Density Residential) for the proposed construction of elderly housing. The recommendation was based on the following; the area is served by public transportation and the traffic study conducted shows that concurrency is met. The application is consistent with goals in the City's Comprehensive Plan and Land Use Element, most importantly Policy 2.1.10 of the Housing Element. Chairman Garcia asked if there was a guarantee that it would be used for elderly housing. Mrs. Gonzalez stated that under the zoning request it could be made a condition. Chairman Garcia asked if it could be made a condition at this time. The applicant did not object. Chairman Garcia mentioned he has spoken to the Mayor about the project and also discussed with adjacent property owners around the lake, whether the applicant would undertake repairs caused by erosion. Mr. Luis Machado, the applicant, came forward and addressed the erosion around the lake and that he would assist them and put forth his best effort. He also stated however that he will not take the responsibility of a retaining wall. Chairman Garcia asked him to outline or describe the limit of his assistance. He would bring in boulders and fill but at no point did he commit to building a retaining wall and stated that he had discussed this issue with Mr. Herrera, former President of the homeowner's association. He also stated there is an issue with the embankment that could preclude him from doing anything at this moment. The public hearing was opened at 7:51 p.m. Mr. Jose "Pepe" Herrera came forward to "represent his community". It was brought to Mr. Herrera's his attention that he was giving his opinion but he did not have the authority to represent the community as a whole without written consent. Mr. Martos, attorney for the applicant, clarified the position of Mr. Herrera as to his actions when he was the President. At this time Mr. Citrin requested a covenant with the land ensuring that the use will be only for elderly housing. Mr. Martos agreed to proffer that covenant next week as a condition. Councilman Gutierrez raised his concerns regarding the traffic on NW 103<sup>rd</sup> Street. Mr. Martos referred to the traffic study which showed concurrency.

Councilman Gutierrez stated that he had read the traffic study but was still concerned because most of the traffic will be heading east. Chairman Garcia stated that he believes there will be less traffic because it will be an elderly community and that is why it needs to be established only for that specific use. Chairman Garcia made motion to approve the ordinance with the condition. The motion was seconded by Councilman Merida with Councilman Gutierrez voting against (3-1).
