# **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, March 6, 2018 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:34 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, Councilman Jorge A. Merida and Councilman Rolando Piña. Also present were Mayor Yioset De La Cruz and Assistant City Attorney Aida Martinez-Ruiz. City Attorney Charles A. Citrin was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor Yioset De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions**: None were offered.
- **6. Review of Minutes: February 20, 2018** Chairman Garcia made a motion to approve the minutes of February 20, 2018. The motion was approved unanimously.
- **7. Public Comments:** None were offered.

# 8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE PURCHASE OF TWO (2) 2018 FORD F-150 VEHICLES TO BE USED BY THE PARKS RECREATION DEPARTMENT; AND WAIVING COMPETITIVE BIDDING; UTILIZING AN EXISTING GOVERNMENT CONTRACT AS ALLOWED BY SECTION 46-119 OF THE HIALEAH GARDENS CODE OF ORDINANCES; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO EXECUTE AN AGREEMENT WITH DUVAL FORD; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the full title of the resolution into the record. Mr. Walter Dubon, Director of Parks & Recreation came forward and addressed the Council. Mr. Dubon explained that this item is for the purchase of two Ford F-150 trucks to keep the Parks & Rec vehicle fleet up to date. Chairman Garcia asked whether Parks & Rec had the funds for both purchases in their current budget. Mr. Dubon answered yes. Mayor De La Cruz asked if these were two new vehicles or if these were going to replace old ones. Mr. Dubon answered that they would eventually begin to phase out old vehicles. Chairman Garcia made a motion to approve the resolution, seconded by Councilman Merida. The item was approved unanimously. (5-0)

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE AWARD OF A CONTRACT FOR THE CITY FIREWORKS ENTERTAINMENT TO EXCELLENT ENTERTAINMENT, INC. D/B/A ADD FIRE ("ADD FIRE") FOR THE CITY'S INDEPENDENCE DAY CELEBRATION; RENEWING THE CITY'S CONTRACT WITH ADD FIRE; WAIVING COMPETITIVE BIDDING; AUTHORIZING THE APPROPRIATE OFFICIALS TO EXECUTE AN AGREEMENT WITH ADD FIRE; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

Ms. Martinez-Ruiz read the full title of the resolution into the record. Mr. Dubon, Director of Parks & Recreation, came forward once again and explained that this item is for the City's Fourth of July fireworks show; this resolution would be approving \$70,000. Mr. Dubon stated that everything has remained the same as in previous years: same vendor, same show, and same specifications. Chairman Garcia made a motion to approve the resolution, seconded by Councilman Merida. The item was approved unanimously. **(5-0)** 

# 9. Second Reading / Public Hearing for consideration and final adoption of the following ordinance:

Ms. Martinez-Ruiz swore in all those who would be testifying and read the full title of the ordinance into the record. Mr. Jorge Szauer, the applicant, was present and came forward. Mrs. Mirtha Gonzalez, Chief Zoning Official, came forward and stated the land use as IN (industrial), Zoning classification IN-1 (light industrial). The applicant is requesting a revision of the approved site plan to develop one building with 65,310 sq. ft. for offices and warehouses, with 64 regular parking spaces and 3 handicap parking spaces. She went on to state TRC's recommendation for approval from January 11<sup>th</sup> (provide fire approval, provide movement on site, billboard access letter). All comments were addressed and on February 12<sup>th</sup>, P&Z recommended the site plan for approval 4-0. Chairman Garcia opened the public hearing at 7:41; no one came forward. Chairman Garcia closed the public hearing at 7:41. He made a motion to approve the ordinance, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(5-0)**

- 12. Reorganization of the City Council's hierarchical order: Ms. Aida Martinez-Ruiz, Assistant City Attorney, led the discussion to reorganize the order of the Council. Councilman Pina nominated Luciano Garcia as Chair, seconded by Councilman Merida. The nomination was approved unanimously. Chairman Garcia nominated Councilman Pina as Vice Chair; the nomination was approved unanimously. Councilman Merida was nominated and voted in unanimously as Finance Officer.
- **13. Board Appointments:** Planning and Zoning Board and Water and Sewer Board. The Council reappointed their nominees to both Boards. Vacancies were discussed.
- **14. City Attorney's Report:** Ms. Aida Martinez-Ruiz expressed that it has been a pleasure to serve the Council while City Attorney Charles Citrin is on vacation.
- **15. Mayor's Report Miscellaneous:** The Mayor also expressed his pleasure at working with the Council and congratulated both Chairman Garcia and Councilman Urra.
- **16.** Council Members Concerns / Reports / Board Appointments: No comments.
- **17. Adjournment:** The meeting was adjourned at 7:50 p.m.
