CITY OF HIALEAH GARDENS TUESDAY, October 16, 2018 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Luciano Garcia called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Chairman Luciano Garcia, Councilman Jorge Gutierrez, Councilman Jorge Merida, Councilman Rolando Piña, Councilman Elmo Urra, Mayor Yioset De La Cruz and City Attorney Charles Citrin.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the pledge of allegiance.
- 5. Deletions/Emergency Additions: N/A
- **6. Review of Minutes: October 2, 2018** Chairman Garcia made a motion to approve the minutes of October 2, 2018. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA AUTHORIZING THE PURCHASE OF PROPERTY EVIDENCE **SOFTWARE** THAT WILL **UPGRADE** THE **POLICE** DEPARTMENT'S CURRENT SYSTEM; AUTHORIZING THE APPROPRIATE CITY OFFICIALS TO ENTER INTO AN AGREEMENT WITH USA SOFTWARE, INC.; AUTHORIZING THE USE OF FORFEITURE FUNDS FOR THIS PURPOSE; PROVIDING **FOR** CONFLICTS; **PROVIDING FOR** SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the item into the record. Captain Michael Lopez, of the Hialeah Gardens Police Department, came forward and respectfully requested the expenditure of \$7,995 for the upgrade of their property evidence software, with forfeiture funds in the LETF (Law Enforcement Trust Fund). USA Software is the current vendor used for all of the HGPD software. The software this will provide for an upgrade to the existing system and will streamline the documentation of property reports. Chairman Garcia asked if there were any comments or questions; none were offered. Chairman Garcia made a motion to approve the resolution; seconded by Councilman Merida. The resolution was approved unanimously.

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, **APPROVING** THE **ENTERING** INTO ΑN INTERLOCAL AGREEMENT BETWEEN THE CITY OF HIALEAH GARDENS AND MIAMI-DADE COUNTY, FLORIDA SUBSTANTIALLY THE FORM AS ATTACHED HERETO AS EXHIBIT "A", RELATING TO THE COUNTY'S PROCUREMENT PROCEDURES WHEN IMPLEMENTING THE BUILDING BETTER COMMUNITIES BOND PROGRAM AND FURTHER AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO THE INTERLOCAL AGREEMENT AND TAKE ANY OTHER ACTION IN FURTHERANCE THEREOF; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the item into the record. Captain Lopez explained that the HGPD is requesting approval to utilize \$152,262.00 which was initially assigned for a mobile command vehicle; however, it has been reassigned for the expansion of the PD building. The PD is outgrowing the building and they intend to use these funds to expand a south wing for their Investigative Division and a Victims Interview Room. The Mayor explained that these are leftover funds from the initial grant amount awarded to purchase the mobile command center. He further stated that because the command vehicle is state of the art and will not need an upgrade in the next

5-10 years, the remaining funds will be better utilized to expand the PD building. Chairman Garcia asked if there were any comments or questions; none were offered. Chairman Garcia made a motion to approve the resolution; seconded by Councilman Merida. The resolution was approved unanimously.

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS AUTHORIZING ENTERING INTO A MUTUAL AID AGREEMENT WITH THE CITY OF MIAMI BEACH, FLORIDA REGARDING LAW ENFORCEMENT ISSUES AND NEEDS; AUTHORIZING THE EXECUTION OF SUCH AGREEMENT BY THE MAYOR; RATIFYING THE PROVISIONS OF SUCH AGREEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the item into the record. Captain Lopez explained they are requesting the renewal of the mutual aid agreement with the City of Miami Beach Police Department which is set to expire in December 2018; the new agreement will be in effect until December 2024. Chairman Garcia asked if there were any comments or questions; none were offered. Chairman Garcia made a motion to approve the resolution; seconded by Councilman Merida. The resolution was approved unanimously.

Mr. Citrin read the item into the record. Mr. Citrin explained that this is basically serves to comply with requirements for a "Share Plan" component in the City's Pension Plan code. Mr. Citrin mentioned that he is going to invite the pension group attorney to come to the next Council meeting for any additional questions. Chairman Garcia stated that this was a first reading and as such there would be an opportunity for public input upon second reading. He then made a motion to

approve the ordinance, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(5-0)**

The Chair made a motion to approve the ordinance, seconded by Councilman Merida. The item was approved unanimously upon first reading. **(5-0)**

The City needs to verify that it's not in that particular road portion. Chairman Garcia stated that this was a first reading and as such there would be an opportunity for public input upon second reading. He then made a motion to approve the ordinance, seconded by Councilman Merida. The item was approved unanimously by individualized voice vote. **(5-0)**
