- **1. Call to Order:** Councilman Jorge Gutierrez serving as Chairman called the meeting to order at 7:32 p.m.
- **2. Roll Call:** Present were Councilman Jorge Gutierrez, Councilman Jorge A. Merida, Councilman Elmo L. Urra, City Attorney Charles A. Citrin and Mayor Yioset De La Cruz, Councilman Luciano Garcia and Councilman Rolando Piña were absent.
- **3. Invocation:** Chairman Gutierrez gave the invocation.
- 4. Pledge of Allegiance: Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions**: None were offered.
- **6. Review of Minutes: December 20, 2016.** Chairman Gutierrez made motion to approve the minutes of December 20, 2016 seconded by Councilman Merida. The motion was unanimously approved.

Mr. Citrin read the ordinance into the record. Mr. Gilberto Pastoriza, attorney for the applicant was present. Chairman Gutierrez stated that this was a first reading and as such an opportunity for public input would be provided upon second reading. Chairman Garcia made motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote (3-0).

10. Second Reading / Public Hearing for consideration and final adoption of the following ordinance:

A) ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE ENTERING INTO AN AGREEMENT WITH FLORIDA COMMUNITY BANK FOR A CAPITAL LEASE NOT TO EXCEED **THOUSAND** ONE HUNDRED **DOLLARS** (\$100,000) FOR THE PURPOSE OF PURCHASING THREE NEW VEHICLES FOR THE POLICE DEPARTMENT: AWARDING THE LEASE CAPITAL TO **FLORIDA** COMMUNITY BANK, N.A.; MAKING CERTAIN COVENANTS AND AGREEMENTS IN CONNECTION THEREWITH; **PROVIDING** FOR THE **ADOPTION** REPRESENTATIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin swore in all those that would be testifying on items for public hearing /second reading. He then read the ordinance into the record. Mr. Citrin stated that no legal opinion would be required and asked that this clause be removed from the term sheet agreement. Mr. Juan Rivera, OMB Director came forward and gave details of the loan to purchase with FCB. Mayor De La Cruz stated at this time that four vehicles could be purchased for the loan amount as the negotiated price was lower. The ordinance will revised to reflect the amount of vehicles purchased. The item was opened for public hearing at 7:44 p.m. No one came forward therefore the hearing was closed at 7:44 p.m. Chairman Gutierrez made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. (3-0)
