#### **MINUTES**

CITY OF HIALEAH GARDENS TUESDAY, August 1,2017 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Councilman Piña serving as Chairman called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Councilman Rolando Piña, Councilman Jorge A. Merida, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, and City Attorney Charles A. Citrin and Mayor Yioset De La Cruz. Councilman Luciano Garcia was absent.
- **3. Invocation:** Councilman Gutierrez gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions**: None were offered.
- **6. Review of Minutes: June 20, 2017,** Chairman Piña made a motion to approve the minutes of June 20, 2017 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

# 8. Proposed Resolutions:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA APPROVING THE RENEWAL OF THE AGREEMENT BETWEEN THE DEPARTMENT OF TRANSPORTATION, STATE OF FLORIDA, AND THE CITY OF HIALEAH GARDENS CONCERNING TURF AND LANDSCAPE MAINTENANCE; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title resolution into the record. Mr. Citrin stated that this was a contract that is renewed with FDOT on an annual basis. Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. (4-0)

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA APPROVING THE RENEWING OF AN INTERLOCAL AGREEMENT BETWEEN MIAMI-DADE COUNTY AND THE CITY OF HIALEAH GARDENS FOR PERFORMANCE OF PROFESSIONAL SERVICES BY MIAMI-DADE COUNTY FOR IDENTIFICATION AND CONTROL OF POLLUTANT DISCHARGES IN SHARED MUNICIPAL SEPARATE STORM SEWER SYSTEMS AND TO NEGOTIATE AND EXECUTE CHANGES TO THE SELECTION OF ACTIVITY PARTICIPATION BY THE CO-PERMITEES; **PROVIDING FOR** CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the full title of the resolution into the record. Mr. Citrin stated that this serves to approve the NPDES interlocal agreement which is being renewed at this time for a term of five years. He then proceeded to read the memo prepared by Mr. Joe Lopez, Public Works Director which detailed the agreement. Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. (4-0)

Mr. Citrin read the full title of ordinance into the record. Mr. Raul Tiza, the surveyor for the project was present. Chairman Garcia stated that this was a first reading and as such an opportunity for public input would be provided upon second reading. Chairman Garcia made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)**

Mr. Citrin read the full title of ordinance into the record. He stated that this was a first reading and as such an opportunity for public input would be provided upon second reading. Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(4-0)** 

C) ORDINANCE OF THE CITY OF HIALEAH GARDENS AMENDING CHAPTER 40, HIALEAH GARDENS POLICE PENSION TRUST FUND, CREATING A SECTION 40-400 OF THE HIALEAH GARDENS MUNICIPAL CODE TO PROVIDE FOR THE CREATION OF A DEFINED CONTRIBUTION SHARE PLAN UNDER FLA. STAT. 185.35; PROVIDING FOR CODIFICATION; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE.

Mr. Citrin read the full title of the ordinance into the record. He stated this was a first reading and as such an opportunity for public input would be provided upon second reading and that an attorney for the Police Pension Board would also be present to answer any questions at that time. Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved. **(4-0)** 

# 10. Second Reading/Public Hearing for consideration and final adoption of the following ordinances:

ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, **APPROVING** Α SITE **PLAN FOR** STORE / VERIZON NEIGHBORHOOD WALMART WIRELESS, CONCERNING **PROPERTY** LEGALLY LOCATED AT 11800 HIALEAH GARDENS BOULEVARD, HIALEAH GARDENS, FLORIDA. FOLIO: 27-2033-067-0010, PROVIDING FOR CONDITIONS; PROVIDING FOR EFFECTIVE DATE. (TRC Vote: 5-0; P&Z Vote: 3-0)

Mr. Citrin swore in those who would be testifying on items for public hearing and proceeded to read the full title of the ordinance into the record. Mrs. Janna P. Lhota, attorney with Holland & Knight, LLC., was present for the applicant. Ms. Lhota came forward and gave a brief description of the application to amend the approved Walmart site plan in order to attach three small cell antennas to the existing building. The antennas would provide better service by bringing a signal inside the store for the Verizon products being sold. Mayor De la Cruz asked about the elevation. Ms. Lhota responded regarding the location and height of each antenna all which will be placed below the roofline and are unobtrusive. Mrs. Mirtha Gonzalez Chief Zoning Official came forward and gave staff recommendation for approval. Chairman Piña inquired if antennas have been installed in any other Walmart stores. Ms. Lhota answered no, but that they were in the process of deploying these across the country. Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. (4-0)

A) ORDINANCE OF THE CITY OF HIALEAH GARDENS, FLORIDA, REPEALING ORDINANCE NO. 2016-20 CONCERNING THE ENTERING INTO AN AGREEMENT WITH FLORIDA COMMUNITY BANK FOR A CAPITAL LEASE NOT TO EXCEED ONE HUNDRED THOUSAND DOLLARS (\$100,000) FOR THE PURPOSE OF PURCHASING THREE NEW VEHICLES FOR THE POLICE DEPARTMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR EFFECTIVE DATE.

Mr. Citrin read the full title of the ordinance into the record. He stated that this is a result of the City making a management decision to purchase the vehicles outright and therefore it was not necessary to enter into a capital lease agreement. Chairman Piña made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice. **(4-0)**
