## **MINUTES**

CITY OF HIALEAH GARDENS WEDNESDAY, September 20, 2017 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Councilman Jorge Gutierrez serving as Chairman called the meeting to order at 7:30 p.m.
- **2. Roll Call:** Present were Councilman Jorge A. Merida, Councilman Elmo L. Urra, Councilman Jorge Gutierrez, and Assistant City Attorney Aida Martinez-Ruiz and Mayor Yioset De La Cruz. Councilman Luciano Garcia, Councilman Rolando Piña and City Attorney Charles A. Citrin were absent.
- **3. Invocation:** Chairman Gutierrez gave the invocation.
- 4. Pledge of Allegiance: Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions**: Item 9B. was deleted and Items 8B, 8C and 8D were added to the agenda.
- **6. Review of Minutes: August 15, 2017,** Chairman Gutierrez made a motion to approve the minutes of August 15, 2017 seconded by Councilman Merida. The motion was unanimously approved.
- **7. Public Comments:** None were offered.

# 8. Proposed Resolutions:

A) RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HIALEAH GARDENS, FLORIDA, AUTHORIZING THE EXTENSION AND AMENDMENT OF A LINE OF CREDIT ISSUED BY FLORIDA COMMUNITY BANK ORIGINALLY IN A PRINCIPAL AMOUNT OF \$2,000,000; AMENDING THE LINE OF CREDIT TO A PRINCIPAL AMOUNT OF PAY COSTS RELATING \$1,250,000 TO TO COVENANTING TO BUDGET AND APPROPRIATE FROM **LEGALLY AVAILABLE** NON-AD REVENUES, TO REPAY SUCH NOTE; VALOREM PRESCRIBING THE FORM, TERMS AND DETAILS OF **PROVIDING** NOTE; FOR SEVERABILITY; PROVIDING FOR CONFLICTS; AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Aida Martinez-Ruiz read the full title of resolution into the record. Mr. Juan Rivera, OMB Director came forward and stated that the line of credit will be extended through August 17, 2018. Mayor De La Cruz took this opportunity to mention that the line of credit serves in emergency situations such as the recent hurricane whereby the city has access to funds until reimbursement is received from FEMA. Chairman Gutierrez made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. (3-0)

B) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S HEALTH INSURANCE BETWEEN AVMED AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR EFFECTIVE DATE.

Ms. Aida Martinez-Ruiz read the full title of resolution into the record. She proceeded to give details of the proposals obtained by the City's insurance broker to provide health insurance coverage for the City's employees. After review of the plans received it was recommended that the City remain with its current insurance carrier, AvMed. Ms. Martinez-Ruiz also recommended the City continue to provide supplemental health insurance to assist the employees with increased deductibles and co-payments, this will be addressed by the following resolution. Chairman Gutierrez made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. **(3-0)** 

C) RESOLUTION OF THE CITY OF HIALEAH GARDENS APPROVING AND RATIFYING THE AGREEMENT FOR THE CITY'S SUPPLEMENTAL HEALTH INSURANCE BETWEEN BEAZLEY INSURANCE AND THE CITY OF HIALEAH GARDENS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTS; PROVIDING FOR EFFECTIVE DATE.

Ms. Aida Martinez-Ruiz read the full title of resolution into the record. She stated that again after review of plans received through the City's insurance broker, it is recommended that the City enter into an agreement with Beazley Insurance which will provide the supplemental insurance coverage to cover hospitalization deductibles and a portion of the co-payments of the AvMed plan. Chairman Gutierrez made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. (3-0)

D) RESOLUTION OF THE CITY OF HIALEAH GARDENS, FLORIDA, APPROVING AND RATIFYING AN AGREEMENT FOR THE CITY'S LONG AND SHORTTERM DISABILITY, ACCIDENTAL DEATH AND DISMEMBERMENT, AND LIFE INSURANCE BETWEEN CIGNA AND THE CITY OF HIALEAH GARDENS, PROVIDING FOR CONFLICTS, PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.

Ms. Aida Martinez-Ruiz read the full title of resolution into the record. She stated that Cigna is company the City has been using for the past three years. The rates have not changed and therefore Ms. Martinez-Ruiz she is recommending to continue with this provider. Chairman Gutierrez made a motion to approve, seconded by Councilman Merida. The motion was unanimously approved by individualized voice vote. (3-0)
