MINUTES

CITY OF HIALEAH GARDENS TUESDAY, FEBRUARY 16, 2016 CITY COUNCIL CHAMBERS 10001 NW 87 AVENUE

- **1. Call to Order:** Chairman Garcia called the meeting to order at 7:35 p.m.
- **2. Roll Call:** Present were Mayor Yioset De La Cruz, Chairman Luciano Garcia, Councilman Jorge A. Merida, Councilman Elmo L. Urra, City Attorney Charles A. Citrin, Aida Martinez-Ruiz Assistant City Attorney and Councilman Jorge Gutierrez. Councilman Rolando Piña was absent.
- **3. Invocation:** Chairman Garcia gave the invocation.
- **4. Pledge of Allegiance:** Mayor De La Cruz led the Pledge of Allegiance.
- **5. Deletions/Emergency Additions**: None offered.
- Review of Minutes: January 19, 2016 Chairman Garcia made a motion to approve the minutes of January 19, 2016 seconded by Councilman Merida. The motion was unanimously approved.
- 7. Public Comments: Grace Loeb founder of Guardian Hands Foundation came forward to invite the Council to the third annual Walk for Rare Diseases event this Sunday, February 28th. She stated that the purpose of the event is to raise awareness for both the public and elected officials and stated that the theme of the event this year is "Making the Voices of Rare Diseases Heard". Ms. Loeb mentioned the petitions on her webpage wherein she needed 99,000 signatures in order to obtain an executive order from President Obama and asked those present to contact their legislators in support of legislation called "Open Act". Ms. Loeb

thanked everyone for their time. No one else came forward. Public comments were closed.

Discussion of proposed expansion to the Angels Reach Foundation/Angels Reach Academy for Divergent Learners School, 10251 W. Okeechobee Road, Hialeah Gardens: Ms. Dorys Luzardo, Founder & CEO came forward and gave details of the request for the expansion of the school which has a current occupancy limit of 250 students. She mentioned that Ms. Melissa March, CEO of iSchools has offered an opportunity to bring their organizations together in order to serve more students a diversity of students, not only the autistic children she currently exclusively serves. Ms. Luzardo stated that she is aware of the concerns regarding traffic in the area and mentioned there had previously been a charter school on this property, with a much-higher student population (approximately 700). Ms. Luzardo said that her students would be limited to 500 and would have staggered arrival and dismissal times. Furthermore, she aims to expand the property by using a previously-built home structure on the site which will serve as a pre-school for 100 of the 500 projected students. Chairman Garcia stated that while he appreciates the proposal, he reminded Ms. Luzardo that the expansion must go through a series of steps with the City such as site plan approval and use of the additional house structure on the property. Chairman Garcia also stated that the project will need to have input from the City boards and other interested parties, such as members of the public. Mayor De La Cruz made comments regarding traffic concerns, addressed by the Police Department, which may occur as a result of an increase in students.

9. Proposed Resolution:

A) RESOLUTION OF THE CITY OF HIALEAH GARDENS, THE AUTHORIZING FLORIDA AMENDMENT RESTATEMENT OF RETIREMENT PLAN VIA ADOPTION OF **RETIREMENT SERVICES VALIC COMPANY** RETIREMENT PLAN FOR GOVERNMENTAL EMPLOYERS; **PROVIDING** FOR CONFLICTS; **PROVIDING** SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

Mr. Citrin read the resolution into the record. Mr. Juan Rivera came forward and introduced Mr. Mike Magdalena of Valic, who was present to answer any questions on the resolution. This matter involves the amendment and restatement of the retirement plan for Valic. Mr. Magdalena stated that there are no changes to the current plan; this is just a restatement to abide by IRS and DOL regulations to keep the plan in compliance. The plan is a 401A, a profit-sharing plan with an employee component. Mayor De La Cruz raised concerns regarding the changes and asked when the documents have to be signed. Mr. Magdalena stated the City has until April 30th 2016 to sign said documents, therefore it was agreed that a meeting will be set up to review the plan and address any concerns. Mr. Citrin

made comments regarding not having a summary of the plan and would like more information regarding its performance, as did Chairman Garcia, who suggested that the plan could be reviewed based on average employee performance. To recap, Mr. Magdalena said he would prepare a summary review of the assets under management by Valic since inception and current changes in mandates by IRS. The Item was tabled.
